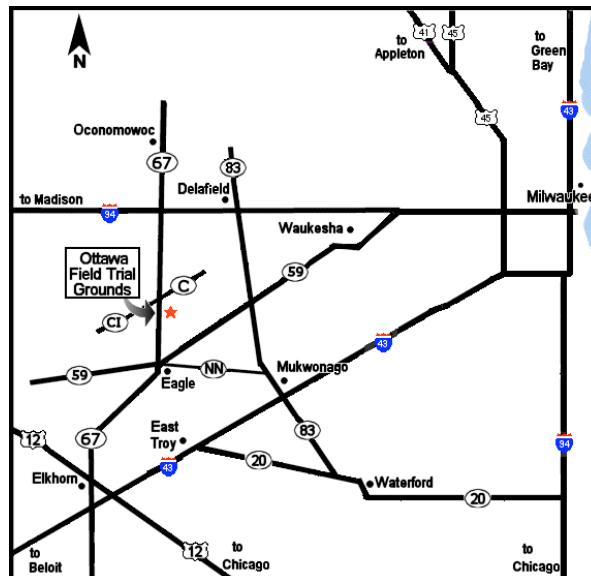
FUNDRAISING
